Subscription and License Agreement

License Agreement ("Agreement")
Growing Up With Us, Inc. ("GUWU")

You or the institution you are affiliated with ("Subscriber"), has obtained a subscription to use the resources available from Growing Up With Us, Inc. ("GUWU"). Definitions
